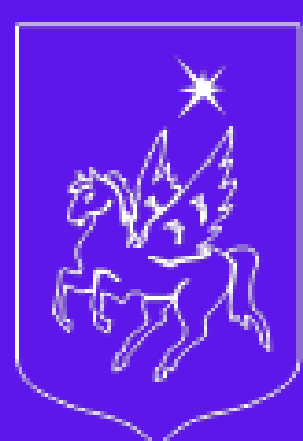

## ENTRY REQUIREMENTS

Applicants with a bachelor's degree, as well as people with a higher professional education, confirmed by the assignment of the qualification "certified specialist", have the right to participate in the competition for places funded from the budget allocations of the federal budget. Admission is based on an entrance test.

## PROGRAM STRUCTURE

The first year includes studying of such subjects as topical problems of civil law, problems of delict liability in civil law, corporate law and others.

The second year focuses on the study of property law, the institute of insolvency in Russian and foreign law, the civil and commercial law of foreign countries, etc.

In addition, there is an internship in the profile of professional activity. The program is finished by the writing of the master's thesis.

## CAREER OPPORTUNITIES

Graduates of the Master's program can work in the judiciary (both the Belgorod Region and other subjects of the Russian Federation), prosecution bodies of any level, commercial and non-commercial organisations and international organisations.
